

ORDERED and ADJUDGED that:

1. The Unopposed Motions to Intervene are GRANTED.
2. Intervenor Plaintiffs shall have the same rights and privileges as all other plaintiffs in this action.
3. The Complaint is hereby adopted by Intervenor Plaintiffs.
4. The definition in the Complaint of "Local Governments" is deemed to include Intervenor Plaintiffs.
5. The Clerk of the Court shall amend the style in this case to reflect the intervention of City of Homestead, Florida, Cooper City, Florida, City of Pompano Beach, Florida, City of North Miami, Florida, Village of Palmetto Bay, Florida, City of Coral Gables, Florida City of Pembroke Pines, Florida, Broward County, Florida, Levy County, Florida, and St. Lucie County, Florida as party Plaintiffs.
