PRECAUTIONARY BOIL WATER NOTICE

Limited Area:

RESIDENCES OF THE COUNTRY ISLES PATIO I COMMUNITY ON THE ROADWAYS OF ATLANTA, BATON ROUGE, TALLAHASSEE, COLUMBIA, CHARLESTON, AUGUSTA, DOVER, RALEIGH, IN THE CITY OF WESTON, FLORIDA

A WATER MAIN BREAK OCCURRED ON COLUMBIA IN THE COUNTRY ISLES PATIO I COMMUNITY IN THE CITY OF WESTON; REPAIRS HAVE BEEN COMPLETED AND THE WATER IS BACK ON.

THEREFORE, AS A PRECAUTION, WE ADVISE THAT ALL WATER USED FOR DRINKING, COOKING, MAKING ICE, BRUSHING TEETH, OR WASHING DISHES BE BOILED. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE PROBLEM HAS BEEN CORRECTED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK.

THE AREA INCLUDES HOMES THAT HAVE ADDRESSES ON THE ROADWAYS: ATLANTA, BATON ROUGE, TALLAHASSEE, COLUMBIA, CHARLESTON, AUGUSTA, DOVER, AND RALEIGH. VIEW ENCIRCLED AREA IN THE MAP ON PAGE TWO OF THIS RELEASE.


